KWIKREZ ACRYLIKOTE WARRANTY



1. Coverage – Manufacturing Defect:

Intelli-Force Technology Corp. warrants it's Kwikrez AcryliKote to be free of manufacturing defects, within generally accepted standards of commercial coatings industry, for one year from date of sale to the original flooring owner / end-user.

2. Coverage – In-Use Defect:

Intelli-Force Technology Corp. warrants through regular use and proper installation it's coating will not delaminate or deteriorate, and that the magnetic receptive strength will not deteriorate within the warranty period.

3. Terms and Conditions:

For a defect reported to Intelli-Force Technology Corp. in writing within one year of purchase date and validated by Intelli-Force Technology Corp., new replacement material, same or similar quality, sufficient to repair or replace defective material and reasonable labor costs will be provided.

4. Warranty Actioning:

- a. Written report of suspected defect should be sent to Intelli-Force Technology Corp. with a copy of original purchase receipt that shows dealer name, address, purchase date, item, quantity, material cost and labor cost.
- b. Upon receipt by Intelli-Force Technology Corp. of above information, arrangements will be made for a Intelli-Force Technology Corp. representative to inspect the material believed to be defective.

5. Warranty Resolution:

If said defect is confirmed, Intelli-Force Technology Corp. will resolve as detailed in Paragraph 3 (Terms and Conditions) above.

6. Warranty Exclusions:

- Damage caused by improper storage and handling prior to installation.
- Material utilized for other than prescribed use per Technical Data Sheet.
- Material installed with obvious defects. Use constitutes acceptance.
- Conditions resulting from installing, utilizing and maintaining coating not in conformance with Intelli-Force Technology instructions for Installing Kwikrez Acrylikote and TDS – most current edition at time of installing.
- Material installed over lightweight aggregate concrete with density less than 90 lbs. / cubic foot or installed over particle board, chip wood, pressboard and similar.
- Situations created by and resulting from excessive moisture, alkali or hydrostatic pressure, mold and mildew, salts, silicates, hydrocarbons, or other deleterious chemical compounds in substrate.
- Situations created by and resulting from flooding, standing water and temperature extremes.
- Indentation and point loading from wheels and high-heeled shoes.
- Situations created by or resulting from absence of or improper or poorly designed furniture rests and floor protectors.
- Telegraphing of adhesive trowel lines, joint lines, underlayment fasteners, etc.
- Situations created by or resulting from lack of or improper protective matting at entryways, landings and pivot points.
- Situations created by or resulting from rubber tipped furniture legs, rubber wheels, mats and carpets with rubber or synthetic backing.
- Damage from on-going work by other constructions trades.
- Surface abrasion and / or change in surface finish from normal use, lack of maintenance or improper maintenance.
- Cuts, scratches, gouges, scuffs, punctures, tears, indentations and burns.
- Discoloration due to insufficient or improper substrate prep, installing procedures, lack of maintenance or improper maintenance.
- Stains and / or discoloration created by or resulting from, but not limited to dyes; inks; fading; contact with synthetic or rubber products (including mat and carpet backing); non-approved adhesive or maintenance products; traffic-born contaminants; spills; and tracked-in-matter including asphalt, resins, driveway sealers, carpet crocking, sunlight, heat generation, plasticizer migration, etc.
- When using over existing flooring, there is no warranty for failure of the coating or the existing flooring due to conditions related to the flooring being covered. There is no warranty or certification installing over asbestos. There is no liability to Intelli-Force Technology Corp. before, during, or after any claims brought or litigation resulting from this product being installed over asbestos based materials on any substrate.

7. Warranty Limitation:

- a. There is no warranty beyond the warranty expressed here.
- b. Intelli-Force Technology liability for loss of profit, other indirect, special or consequential damages are specifically excluded. This warranty shall not include loss of time, inconvenience, incidental expenses (such as telephone calls, labor and/or materials) incurred in the removal or reinstallation of the affected material, and any other incidental or consequential damages. Some states do not allow the exclusion or limitation of incidental or consequential damages. In such cases, the above limitation and exclusion may not apply. Your warranty gives you specific legal rights; other legal rights, which vary from state to state may be applicable. Remedies contained herein are the only remedies available for breach of the warranty.
- c. Intelli-Force Technology Instructions for Installing Kwikrez Acrylikote can be updated at anytime. Reference should always be to most current edition at time of installing.
